

Please read the following disclosures/agreements below following:

- 1. I understand that the airbrush tanning process uses a product that is applied to the body which contains Dihydroxyacetone (DHA). DHA is FDA approved for cosmetic use. The process results in a golden tan appearance that usually lasts three to ten days if post-tan protocol is followed.
- 2. I understand that all ingredients in the tanning product used in this procedure are for cosmetic use only and generally regarded as safe. Though rare, I acknowledge that it is possible allergic reaction could occur from one or more ingredients in the spray-tan solution. Should allergic reaction occur, I agree to not hold liable SunKissed by Kris<sup>™</sup> or proprietor, Kristina Thornberry.
- 3. I understand airbrush application of the DHA solution produces color ("tan") on the epidermis (the outermost layer of my skin). My epidermis sheds daily, cell by cell, which will result in a gradual reduction of my tan. I acknowledge that my spray tan will last generally about three to ten days. Long and hot baths or showers, hot tubs, swimming pools with chlorine, perspiration, and/or scraping, scratching, or rubbing my skin could all shorten the life of my tan. I understand it is extremely important to moisturize my skin two times daily and it is recommended I use a quality lotion product which contains tan extender. Tan extender lotion is available for purchase from SunKissed by Kris™ or from other select distributors and salons.
- 4. I understand there is a small percentage of people whose skin does not react favorably to spray-tanning. SunKissed by Kris<sup>™</sup> does NOT recommend first-time clients receive a spray-tan prior to a critical appearance or event. If you are a first time spray-tanning client and want to be tanned prior to a wedding, photographic session, modeling assignment, body-building show, or other special occasion, it is recommended you first tan a month or so in advance to make sure all goes well, then again just prior to your event.
- 5. I understand the airbrush tanning solution will not protect my skin from burning in the natural sun or in a tanning bed and I will take precautions when out in the sun or tanning with a UV light exposure.
- 6. I understand the tanning solution could stain garments worn during my tanning session and therefore it is recommended I wear dark-colored undergarments or a bathing suit during my spray tan. I acknowledge that even when my tan is dry and I am redressed, the initial bronzer could transfer to my clothing. This is more likely to occur if I perspire due to any physical activity prior to my initial shower after the tanning process. SunKissed by Kris™ bronzers are water soluable and wash out of most materials, but may be stubborn on synthetic fibers.

- 7. I understand that the Sunkissed by Kris<sup>™</sup> airbrush tanning method is designed to provide the most evenly colored and dispersed tan on my skin. However, everyone's skin is different which may leave some areas of my tan lighter or darker than others. In most cases, these differences in color/tone are temporary and minor and usually disappear after showering. After showering, pat-drying is recommended to help preserve the evenness and overall life of my tan.
- 8. I understand that if I have a history of asthma or other respiratory or medical condition that could be aggravated by the airbrush tanning application process, I should consult my physician before proceeding.
- 9. I understand that if I am pregnant, I am proceeding with the airbrush tanning application at my own risk. I have discussed airbrush tanning with my physician and received permission to proceed with the tanning application process. If I am nursing, I agree to wear a garment on top.
- 10.1 understand that parents of minors under the age of 18 must be present during the airbrush tanning application session and must provide written permission for their child to proceed.
